Mr Burke has more than ten years' funds management experience. He was formerly Managing Principal – Head of Distribution at Nucleus Global Investors, a role he held in Sydney and London. Prior to this, Mr Burke held distribution roles at Mariner Financial Ltd and Zurich Financial Services.
